The name of this corporation is HIGH DESERT DOMESTIC VIOLENCE PROGRAM

II.

A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

B. The specific purpose of this corporation is to organize and maintain a program to provide counseling, physical support and other services to individuals who are the victims of domestic violence.
